Minutes for the special session of the Council of the Town of Anmoore held Monday June 19, 2017 at the Anmoore Fire Dept/Council Chambers, 158 Ash Street Anmoore, WV at 7:45 PM

The meeting was called to order by Mayor Shannon Fragmin at 7:45 PM.

Mayor Shannon Fragmin appointed Council member Kristina Palmer as acting Recorder

ROLL CALL: Mayor Shannon Fragmin, Council members Wendy Posey, Chad Palmer and Kristina Palmer are present. Council members Anna Harvey, Randy Critchfield and Amanda Cahill were absent.

After roll call, the Council proceeded with the following business:

CANVAS OF ELECTION

The council members present met immediately after the regular session meeting as the board of canvassers.

Council chose not to set a bond amount for recount because everyone running in this election ran unopposed.


The ballot box was unlocked and the contents removed. The number of ballots received was 500; which included 457 unused ballots, 43 voted ballots, and 0 spoiled ballots.

One correction took place on the statement of ballots used that had been filled out by the poll workers. This sheet stated we had 470 unused ballots. After hand counting ballots, this number was correct to 457 unused ballots. After this correction, all numbers of ballots matched.

If no call for recount is received by 8:45 Pm, Wednesday June 21, 2017, the election will become final and the results (see page 3) will be certified as official.

Motion to adjourn was made by Chad Palmer, 2nd by Wendy Posey. Motion passed unanimously.
